

What is *Digital Fascism*?

Everybody understands the tyranny of the timeclock. When you work for an employer that has one, your life for the work week revolves around the control imposed by that clock. And with the control of the timeclock, comes the virtual bullwhip for performance. It's used like an ax over your head during the timeframe of your work schedule. In the past, when you left work, the tyranny ended and you were free from control until your next workday. Digital Fascism is tyranny of the timeclock coupled with "performance measurements" that doesn't end at the end of the workday. Rather, Digital Fascism encompasses your entire life - birth to death and every second of time in between.

Background

In 1995, when the United States Congress voted to approve the Uruguay Round of the GATT, they voted to regress the world back to the days of human beings as commodities for trade. The Uruguay Round included "Trade in Services". A "service" equates to a human body - whether skilled or unskilled makes no difference. It is human flesh as a tradable commodity.

Since that sounds unbelievable, I offer you the words of [Jose Maria Aznar, President of the Government of Spain, on behalf of the European Union](#) (emphasis added):

*One of our shared concerns brings us together today at this, the Monterrey Conference: the unbearable situation of a large part of Humanity. It is not just a moral concern based on ethics. **It is also the conviction that it is necessary to extend to everyone, that is, to every human being who inhabits the earth, the opportunities enjoyed by the citizens of developed countries.***

We have come, then, not only to reflect, but also to act, to make the world we live in a more just, more prosperous and better place, with our sights set not on abstract considerations, but on concrete human beings.

In this sense, I sincerely believe that the Monterrey Conference is an important step in a process which the International Community as a whole decided to support at the Millennium Summit. Monterrey, along with Doha and Johannesburg, is and will be a name associated with the effort to concertedly confront the varied aspects of development.

Because global challenges require global responses. This is the great potential of the well-named Monterrey Consensus. We are without a doubt facing the important renewal of a universal pact to eradicate poverty. This pact is based on the firm engagement of some, and on a conviction: no one is condemned to poverty or underdevelopment. Every country has a potential for creativity and growth which must be freed.

Based on the conviction that international trade is an authentic engine for development, the European Union is firmly committed to leading the development agenda agreed in Doha, with special emphasis on the liberalization of markets. The European Union is in fact the main export market for developing countries and offers generous trade preferences. **Furthermore, the EU has marked the appropriate path with the "Everything but Weapons" initiative, which concedes access with no tariffs or contingencies for exports of Least Developed Countries.**

Generous of them don't you think? To promote the idea of importing people from the poorest countries to "unleash their creativity" in the developed world - competing with the "creativity" of people in the developed world.

Buyer's Market

Since there are conservatively 3 billion poor people in the world who would be rather desperate to migrate to the developed world, the Monterrey Consensus created a buyer's market in labor. A once incomprehensible story out of [Yakima Washington](#) regarding imported Thai apple pickers is understandable in view of the Monterrey Consensus. The irony is that the apple picking jobs were traditionally held by poor Mexican farm labor migrants who now have to compete with imported Thai apple pickers. The result of the Monterrey Consensus is that you have people competing against people for the few jobs creating a [Buyer's Market in labor - perfect conditions for exploitation - globally](#).

The above describes the lowest level of work in the U.S. labor market but the slave trade is not limited to those jobs. In fact, the impetus for global slave trade came from the [Financials Industry](#) who simply couldn't stand paying middle class wages to Americans when technology provided the potential for a world of people for them to exploit. White collar labor imported to compete in the '[race to the bottom](#)' are imported on H-1B, L1 and some 60 or so other visas. When one reorients their thinking to understand the treason of the international agreements for the benefit of the Financials industry, the propaganda campaigns of the "aging workforce" and "shortages", etc. make sense. Relative to the entire world's population, the relative percentage of people over 40 in the United States would appear to make the U.S. population to be "aging". And relative to the entire world's population, the availability of people willing to work at a "world price for labor" would create a shortage - an artificially created shortage relative to the projected 'end of useful productive life' in a world of global labor arbitrage.

In a previous paper titled, [Digital Fascism of the Dons of Davos](#), I described and gave links to the international summits (G7-G8) of the leaders of the developed countries where they agreed to betray the citizens of their respective nations for the benefit of roughly a thousand of the leaders of multinational corporations. Those summits were merely ceremonial. The detail plotting and planning for creating a one world fascist, totalitarian system were worked out before those public meetings were held. That planning included the "reforms" of domestic policy to ensure the chains of control for their domestic populations were in place as the "transformation" to a global system of slavery of the

masses was implemented. In addition, a Big Lie propaganda campaign was concocted to "sell" the initiatives that were necessary to create the conditions that would enable the transformation. Those initiatives were given sound bite labels that created illusions of benefit to their populations - Free Trade, Sustainable Development, High Performance Education, 21st Century Economy, Renewable Energy, etc. When you dig below the surface of the attractive labeling, what you find is pure evil support for the totalitarian system of control. And once the systems of totalitarian control are in place, there will be no escape for the world's people because the controls are too all encompassing and insidious.


Case in point on what I'm talking about when I discuss 'Digital Fascism'.

The following diagram is intended to provide a rough idea of population management systems that are being implemented to control and plan the utilization of the resident population of the territory being managed by the local eGovernment façade for the international, Global Slave Masters.

It is imperative given the speed of the "transformation" of our country, that people understand in stark terms what it all means and how it is going to effect their children and grandchildren. These systems are Corporate Population Management Systems. Under the new system, your heirs will be no different than work animals for their corporate masters.

Population Management



I'm not going to describe all of the systems here because I and others have described them in other places individually. The exception is the significance of the Real ID because all other systems are predicated on "uniform, positive identification" for the lifetime of the "human asset". The most important thing to understand about these systems is that they were designed to be an integrated, population control system that will monitor, measure and record every breath you take - every move you make - just like the song says.

Real ID

In the global system of population management, everybody will need to have an absolutely certain, positive identifier regardless of what country they come from. Though it's not advertised, you can be assured that the national identification systems that are being implemented all have a compatible numbering system - which includes country of origin. Finger prints and biometric identifiers like iris scans are useful for some purposes, but they don't meet the requirements of other useful applications for population management. The only "real ID" that will meet the requirements of all the management systems is the embedded RFID chip. There are rumblings that these chips cause cancer - but this is not important in a global system of labor supply. In fact, it's useful. It's a like self-destruct feature for "over age" workers.
