

## Illegal Invasion: State Sponsored Terrorism as a Tool for Change Management

Between 2004 and 2005, it became clear that our country was being invaded by illegals – by media accounts – mostly from Mexico. That was occurring at the same time that Indians from India were arriving by the plane load to take IT and engineering jobs while the Mexicans were taking blue collar jobs. At the same time, U.S. corporations were leaving the country and as a result, massive layoffs were occurring. [Tom Tancredo]: It is amazing to recognize the following:

In 1990, the U.S. passed a series of immigration laws. They were sponsored by a member of the other body from Massachusetts, and it instructed the State Department employees that mere membership in a terrorist organization or advocacy of acts of terrorism should not exclude foreigners from receiving U.S. immigration visas. Mere membership in these kinds of organizations should not exclude anyone from getting a visa.

That was Ted Kennedy of course.

In the Senate version of legislation, they defined the meaning of Commonwealth in the context of the legislation –

This Act may be cited as the `Commonwealth and Baltic Scientists Immigration and Exchange Act of 1992'.

#### SEC. 3. DEFINITIONS.

For purposes of this Act—

(1) the term `Baltic states' means the sovereign nations of Latvia, Lithuania, and Estonia;

(2) the term `Commonwealth of Independent States' includes the sovereign nations of Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Turkmenistan, Ukraine, and Uzbekistan;

Back to 2005 - When Lou Dobbs put a spotlight on the issue, Tancredo finally received the attention he wanted for immigration reform. Once the country was all whipped up into a fervor and on the verge of a civil war, Tom Tancredo introduced legislation that supposedly was going to fix the problem. The legislation was H.R. 3333 – “The Real Guest Act of 2005”.

Tancredo’s legislation contained this nugget that would have given the U.S. Secretary of Labor management authority over the entire U.S. labor market. Why? Because it’s not possible to manage a guest worker system without managing domestic workers as well. (Note: the America’s Job Bank system was already operational) –

H.R. 3333

To enhance border enforcement, improve homeland security, remove incentives for illegal immigration, and **establish a guest worker program**.

(a) Short Title- This Act may be cited as the `Rewarding Employers that Abide by the Law and Guaranteeing Uniform Enforcement to Stop Terrorism Act of 2005' or the `REAL GUEST Act of 2005'.

*SEC. 102. INTERNET-BASED JOB POSTING SYSTEM*

*(a) In General- The Secretary of Labor shall take any steps necessary to ensure that all State employment agencies and all employers in the United States are able to acquire secure, password-protected access to the Internet-based job database provided jointly by the Department of Labor and State employment security agencies and known as `America's Job Bank' in order to permit the posting of job openings throughout the United States*

*(2) CESSATION- If compensation, including real wages, benefits, and working conditions, in a particular occupational category in a geographic region has been stagnant or in decline for the 6-month period immediately preceding the filing of a petition for an H nonimmigrant worker, the Secretary shall not approve the petition until--*

*(A) compensation in that occupational category and geographic region has increased each month for at least 6 months by an amount to be determined by the Secretary; and*

*(B) the Secretary has reassessed the prevailing wage for that occupational category and geographic region to ensure that it reflects the rising real wage levels.*

#### *SEC. 103. REQUIREMENTS FOR PROSPECTIVE EMPLOYERS OF H NON-IMMIGRANTS*

*(c) Announcement Contents- Each job announcement posted pursuant to this section shall list, at a minimum, the following:*

*(1) The name, contact information, and description of the employer*

*(2) A description of the job and the minimum skills necessary to perform it.*

*(3) A description of any additional knowledge, skills, or abilities that are preferred by the employer*

De facto, ALL employers would have had to list their jobs on the job bank so that the Secretary of Labor could determine what jobs are available, what they are paying and how many Americans are looking for work in that category if even a single employer has a request for a foreigner to fill a job in that category.

This was the means by which they would have seized control of our economy and our citizens for forced participation in the 'Human Resources Management' - America's job bank system and future generations of Americans would no longer be free people.

Tom Tancredo left Congress years ago, but I kept a copy of the press release that was posted on his website about the "highlights" of *The Real Guest Act of 2005* (which by the way can still be viewed on the Library of Congress website – Thomas.

Notice the last item on the list concerning reimbursement for medical care for illegals.

Whoever writes the legislation for Congress are so clever in how they do things. A few years later, a Democrat from North Carolina introduced legislation for something called The SAVE ACT. You can read about here:

On September 10, 2001, "The Special Routing Arrangement Service (SRAS), which is run by the National Communications System (NCS), is turned on for "exercise mode," meaning it is ready to be utilized the following day in response to the terrorist attack. The SRAS was developed for Continuity of Government emergency planning in the event of war on the United States. On September 11, 2001, the FEMA Continuity of Government program was activated. Invocation of Continuity of Government suspends the Constitution. Excerpts:

The NCS consists of 22 federal agencies, 100 full-time civilian employees, and 10 military employees. [Computerworld, 11/7/2002] The mission of the NCC is to assist “in the initiation, coordination, restoration, and reconstitution of national security or emergency preparedness telecommunications services or facilities under all conditions of crisis or emergency.” The center is composed of members from the US government and the telecommunications industry. [US President, 4/3/1984; National Communications System, 3/2001, pp. 4, 6 - pdf recovered from the Internet Archive: [NCS - March 2001](#) ] There are 150 private sector contractors from 21 companies working at the NCC. "The program, though, is extraconstitutional, as it establishes a process for designating a new US president that is nowhere authorized in the US Constitution or federal law."

"No Role for Congress - According to one participant, “One of the awkward questions we faced was whether to reconstitute Congress after a nuclear attack. It was decided that no, it would be easier to operate without them.” Thus the decision is made to

abandon the Constitutional framework of the nation's government if this plan is ever activated."

In his book titled, *Against All Enemies*, Richard Clarke also said they instituted Continuity of Government. In 2011, Dana Priest's research was featured in a Frontline program called *Top Secret America*. In the program she reports on command, control, surveillance systems that were all ready to go – and were operational and in exercise mode for September 11, 2001.

On September 12, 2001, [NATO](#), for the first time in the organization's history, invoked Article 5 of the Washington Treaty. The [Washington Treaty](#) was signed on April 4, 1949. It provides for Collective Defense under the auspices of the United Nations - which by the way, is not an organization of nations. It only started out that way but has evolved into an organization of regions and associations as nation-states are collapsed. Just recently, I watched a video produced by an incensed American soldier (retired) who said that for the first time ever, there is a German Commander (General?) over American troops in Europe.

<p>After 9/11, there were consultations among the Allies and collective action was decided by the Council. The United States could also carry out independent actions, consistent with its rights and obligations under the United Nations Charter.</p> <p>On 4 October, once it had been determined that the attacks came from abroad, NATO agreed on a package of eight measures to support the United States. On the request of the US, it launched its first-ever anti-terror operation - Eagle Assist - from mid-October 2001 to mid-May 2002. It consisted in seven NATO AWACS radar aircraft that helped patrol the skies over the United States; in total 830 crew members from 13 NATO countries flew over 360 sorties. This was the first time that NATO military assets were deployed in support of an Article 5 operation.</p>

	<p>On 26 October, the Alliance launched its second counter-terrorism operation in response to the attacks on the United States, Active Endeavour. Elements of NATO's Standing Naval Forces were sent to patrol the eastern Mediterranean and monitor shipping to detect and deter terrorist activity, including illegal trafficking. In March 2004, the operation was expanded to include the entire Mediterranean.</p>

In the first quarter of 2002, John Ashcroft former Senator and former member of the Senate Telecommunications Committee announced a “war time reorganization” of the Justice Department. One of the things he announced was the appointment of a crook, Larry Thompson, to the Justice Department to head up a new council, the National Security Coordination Council.

Now, before I turn this even over to the deputy attorney general, I would like to mention and discuss the DNA samples being taken from detainees at Guantanamo Bay.

Currently, the United States government is collecting and using the collection of DNA samples as a standard identification tool of these detainees. And as we discussed yesterday, the FBI oversees the combined DNA index system, or what is called CODIS. That's the national DNA index. While the law does not currently allow law enforcement to collect DNA samples and use them, the law --pardon me, let me just start that again -- the law does allow law enforcement to use DNA samples. The law does not allow these samples to be entered into the DNA database because the samples do not fit categories currently housed in CODIS. What I'm saying is that the samples collected from detainees in the war effort are not among the categories that would currently fit in the CODIS system. We believe that this law should be changed.

The Department of Justice is currently reviewing a legislative proposal that would allow these samples to be entered into the CODIS system, and that would assist law enforcement officials in the identification of those who might seek to harm the United States and U.S. interests through terrorism, either now or in the future.
